**ORDINANCE NO. 5328**, April 20, 2020

**INTRODUCED BY** Charlie Franklin, County Legislator

WHEREAS, the Prosecuting Attorney's Office has been awarded a grant in the amount of \$73,613.33 by the Missouri Department of Public Safety for a program focused on prevention and prosecution of sexual assaults in the County; and,

WHEREAS, this grant partially funds the salaries of three full-time assistant prosecutors for this

program; and,

WHEREAS, the Prosecuting Attorney's Office is proposing to utilize \$461,951.97 from within its budget to complete funding for the project; and,

WHEREAS, a transfer and appropriation are necessary in order to place the required funds in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer and appropriation be and hereby are made:
