WHEREAS, the TIES program is funded by a grant awarded by the United States Department of

WHEREAS, these funds are subject to a local match; and,
WHEREAS, the Prosecuting Attorney has reviewed this proposal and recommends the expenditure
of these funds; therefore,
BE IT RESOLVED, by the County Legislature of Jackson County, Missouri, that the County Executive
is hereby authorized to execute a cooperative agreement with Children's Mercy Hospital, as a loca
grant match for the TIES program in the amount of \$93,750.00, in a form to be approved by the
County Counselor; and,
BE IT FURTHER RESOLVED, that the Director of the Department of Finance be and hereby is
authorized to make all payments, including final payment on the Agreement.
