### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE amending the districts established by the Jackson County Zoning Order by changing from A (Agricultural) to RE (Residential Estates), a certain 3 ± acre tract.

#### **ORDINANCE #3258,** June 10, 2002

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "RE" (Residential Estates) District so that there will be transferred from District A to District RE a tract of land described as follows:

Description: A 3 ± acre tract of land generally south of Nebgen Road on the west side of Corn Road and specifically described as:

A Tract of land in Jackson County, Missouri situated in the SW 1/4 of Section 14, Township 48, Range 30 being more particularly described as:

Commencing at the Northeast Corner of the Southwest 1/4 of said Section 14; thence S 00°01'59"E measured (S00°13'18" deed) along the East line of said Southwest 1/4, a distance of 647.75 feet measured (647.69 feet deed); thence N89°59'52"W measured (S90°00'00"W deed), 43.20 feet to the TRUE POINT OF BEGINNING AT A POINT ON THE West Right of Way of CORN ROAD; thence continuing N89°59'52"W measured (S90°00'00"W deed), 340.52 feet; thence N00°13'41"E, 383.76
feet; thence N90°00'00" E, 340.52 feet to said West Right of Way of Corn Road; thence S00°13'41"W
along said West Right of Way, a distance of 383.77 feet Returning to the Point of Beginning.
Containing 3.00 Acres Subject to Road Right of Ways and Easements (Public and Private) as may

<u>Section 2</u>. The Legislature, pursuant to the application of Eric and Deanna Cross (RZ-2002-263), requesting the amendment embodied in this ordinance and with notice that the Jackson County Plan Commission unanimously recommended this application in a public hearing on May 16, 2002, does adopt this ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
