A RESOLUTION awarding a contract for the furnishing of batteries for the Department of Corrections' LRT scanners to Symbol Technologies of Holtsville, NY, at a cost to the County not to exceed \$5,000.00, as a sole source purchase.

RESOLUTION #13253, June 19, 2000

INTRODUCED BY Terry Young, County Legislator

WHEREAS, Section 1040.1 of the Jackson County Code, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends an agreement with Symbol Technologies of Holtsville, NY, for the furnishing of batteries for the Department of Corrections' LRT scanners; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with

regard to said contract for the reason that Symbol Technologies of Holtsville, NY, is the only known supplier providing batteries for its own LRT scanners; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County an agreement with Symbol Technologies of Holtsville, NY, in an amount not to exceed \$5,000.00; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
