WHEREAS, by Resolution 12898, dated October 4, 1999, the Legislature did award a term and supply contract to Necco Coffee of Kansas City, MO, for the furnishing of coffee service; and,

WHEREAS, Necco Coffee has agreed to extend this service for a period of three months, in the estimated amount of \$7,000.00; and,

WHEREAS, the Purchasing Director recommends this extension; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the contract be

extended as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the extension; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agencies have heretofore been made in the current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
