INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the Parks and Recreation Department has applied to the Jackson County Board of Services for the Developmentally Disabled for funding assistance for the Department's Special Recreation Division; and,

WHEREAS, the Board has agreed to provide a maximum sum of \$168,749.00, to assist the Division with its United Cerebral Palsy Sports, Special Olympics, exception leagues, day camps, classes, and social events programs; and,

WHEREAS, execution of an agreement with the Board is in the best interest of the health, safety, and welfare of the citizens of the County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute a contract with the Jackson County Board of Services for the Developmentally Disabled in a form as approved by the County Counselor...Attorney
