ORDINANCE #4102, May 4, 2009

WHEREAS, a driver in a Missouri traffic accident has a 1 in 31 chance of being killed if he or she is not wearing a seat belt and, in cases in which the driver was wearing a seat belt, his or her chance of being killed decreases to 1 in 1,300; and,

WHEREAS, to combat this situation, the Sheriff's Office has been awarded a grant in the amount of \$5,000.00 by the Missouri Safety Center in furtherance of the Center's Click It or Ticket Overtime Enforcement program for the period May 18, 2009, through May 31, 2009; and,

WHEREAS, the Sheriff recommends the use of funds for reimbursement of overtime used for the Click It or Ticket Overtime Enforcement program pursuant to the attached contract with the Missouri Safety Center; and,
