WHEREAS, Facilities Management, a division of the Public Works Department, intends to take over

the responsibilities with existing staff and with the addition of three employees; and,

WHEREAS, an appropriation is necessary to cover the costs of janitorial equipment, cleaning supplies, and restroom supplies; and,

WHEREAS, the County Executive recommends this appropriation; now therefore,
