WHEREAS, the County has a need to provide parking spaces for County employees near the downtown Kansas City location of the Jackson County Courthouse; and,

WHEREAS, the Kansas City, Missouri School District has parking spaces that are directly across the street from the County Courthouse; and,

WHEREAS, these parking spaces are available at the rate of \$42.00 per month compared to the \$65.00 per month the County is currently paying, which will result in a savings of \$13,800.00 annually;
