WHEREAS, the United States Executive Office of the President's Midwest High Intensity Drug Trafficking Area (HIDTA) Investigative Support Center has allocated a total of \$57,000.00 for fiscal year 2009 for a part-time financial analyst to be hired by the Jackson County Sheriff's Office; and,
