RESOLUTION #11973, December 1, 1997

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the University of Missouri at Kansas City's UMKC Addictions Training Center is a substance abuse training program which emphasizes training of certified counselors employed by Jackson County treatment providers, provides vocational resources for training and continuing education for professionals, and applies new knowledge and skills to the practice of treatment and prevention to improve outcomes of COMBAT-funded initiatives; and,

WHEREAS, the University has requested \$150,000 in local matching funds to secure its 1997-98 grant from the Center for Substance Abuse Treatment (CSAT) in the amount of \$453,600.00; and,

WHEREAS, the Prosecuting Attorney has carefully reviewed this proposal from the University and recommends the expenditure of these funds; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to execute the attached Agreement, a copy of which is incorporated herein by reference, with the Curators of the University of Missouri at Kansas City; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payments on this Agreement...Attorney

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
