WHEREAS, the Prosecuting Attorney has been negotiating with the St. Louis-Kansas City Carpenters Regional Council (the Union) regarding the employment terms and conditions of members of its bargaining unit within the Prosecuting Attorney's Office; and,

WHEREAS, the Prosecuting Attorney and the Union have concluded their negotiations and recommend approval of the proposed Memorandum of Understanding, a copy of which is attached

hereto; and,

WHEREAS, the Union's bargaining unit has ratified the proposed Memorandum of Understanding;
and,

WHEREAS, the approval of this Memorandum of Understanding is in the best interest of the health,
welfare and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Prosecuting
Attorney be and hereby are authorized to execute the attached Memorandum of Understanding on
behalf of the County.
