### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** authorizing the County Executive to execute a Cooperative Agreement for animal shelter services with Wayside Waifs, Inc., of Kansas City, MO, at an actual cost to the County not to exceed \$25,000.00.

**RESOLUTION #16786**, January 7, 2009

**INTRODUCED BY** Bob Spence, County Legislator

WHEREAS, Wayside Waifs, Inc., is willing to provide animal shelter services for the temporary shelter of small domestic animals and the proper disposal of dead animals, for use by the County; and,

WHEREAS, the County desires to use these services as part of its comprehensive animal control program; and,

WHEREAS, the Cooperative Agreements sets forth the mutual responsibilities and obligations of the parties for provision and payment of the services described above; and,

WHEREAS, this Agreement is recommended by the Public Works Department's animal control program staff; and,

WHEREAS, the term of this Agreement shall be for one year commencing on January 1, 2009, and may be renewed on an annual basis thereafter for up to three years at a cost not to exceed a 5% increase for each annual term; and,

WHEREAS, this Agreement is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Cooperative Agreement with Wayside Waifs, Inc., of Kansas City, MO, for animal shelter services, at a cost to the County not to exceed \$25,000.00; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the Agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
