INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, the 2009 County budget contains appropriations from the County's Health Fund for Swope Health Services to provide various public health services to the County and its citizens; and,

WHEREAS, Swope Health Services will provide various public health services, including a community health project, healthcare for the homeless, and a mental health court diversion program;

and,

WHEREAS, the execution of a Cooperative Agreement with Swope Health Services is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute a Cooperative Agreement with Swope Health Services, in an amount not to exceed \$132,250.00, in a form to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
