**INTRODUCED BY** Dennis Waits, County Legislator

WHEREAS, by Resolution 14355, dated October 28, 2002, the County and Entercom - Kansas City, LLC, did enter into a License and Professional Agreement, whereunder Entercom agreed to sponsor an event at Longview Lake, in connection with the County's "Christmas in the Park" program, featuring a synchronized fireworks display and other entertainment and related activities, at cost to the County of \$7,500.00; and,

WHEREAS, since the execution of this agreement, Entercom has requested the modification of several of the agreement's technical provisions relating to insurance, defense, and indemnification; and,

WHEREAS, the requested modifications are contained in the attached Addendum to License and Professional Services Agreement, and do not significantly alter the rights and obligations of the parties; and,

WHEREAS, the execution of the attached addendum is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore.

**BE IT RESOLVED** by the County Legislature of Jackson County, Missouri that the County Executive

be and hereby is authorized to execute the attached Addendum to License and Professional Services Agreement with Entercom - Kansas City, LLC.
