**INTRODUCED BY** James D. Tindall, County Legislator

WHEREAS, by order of the Circuit Court, special prosecutors are appointed to handle the prosecution of particular cases, most often when the Prosecuting Attorney's Office has a conflict of interest in the matter; and,

WHEREAS, special prosecutor Michael M. Spiegel has submitted an invoice in the amount of \$2,873.00 for special prosecutor fees which have been found to be reasonable and necessary by

order of the Circuit Court; and,

WHEREAS, an appropriation is necessary to cover the cost of the special prosecutor; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
