WHEREAS, the Parks and Recreation Department has applied to the Jackson County Board of Services for the Developmentally Disabled for funding assistance for the Department's Special Recreation Division; and,

WHEREAS, the Board has agreed to provide a maximum sum of \$170,277.00, to assist the Division with its United Cerebral Palsy Sports, Special Olympics, exception leagues, day camps, classes, and social events programs; and,

WHEREAS, the attached contract sets out the rights and obligations of the parties; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached contract with the Jackson County Board of Services for the Developmentally Disabled.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
