WHEREAS, the County did, by Resolution #9463, dated November 2, 1992, enter into a contract with Lenz Machinery Co., Inc., of Kansas City, MO, in the estimated amount of \$15,518.00 for the maintenance of laundry equipment for use by the Department of Corrections; and,

WHEREAS, the proposed increase and extension to this contract is necessary to keep the laundry equipment operational for future years, and this increase will not exceed \$16,000.00; and,

WHEREAS, a transfer within the 1995 General Fund is necessary to cover this maintenance; and,

WHEREAS, the County Executive has recommended said transfer; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be made within the 1995 General Fund:
