WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 76-95 for the furnishing of electrical supplies and tools for use by various departments; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in estimated awards to the respective vendors as follows:

VENDOR	AWARD
Western Extralite Kansas City (Jackson County), MO	\$40,000.00
Shaw Electric Co. Kansas City (Jackson County), MO	\$15,000.00
KC Electrical Kansas City (Jackson County), MO	\$15,000.00

therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of

the award; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agencies have heretofore been made in the current Jackson County budget...Attorney
