WHEREAS, the Children's Connection program is funded by the St. James United Methodist Church

and Kairos United Methodist Church, in the aggregate amount of \$15,000.00; and,
WHEREAS, these funds are subject to a local match in the amount of \$15,000.00; and
WHEREAS, the Prosecuting Attorney has reviewed this proposal and recommends the expenditure
of these funds; therefore,
BE IT RESOLVED, by the County Legislature of Jackson County, Missouri, that the County Executive
is hereby authorized to execute the attached cooperative agreement with 40 Acres and A Mule
Campus, to provide a local grant match for the Children's Connection program at a cost to the County
not to exceed \$15,000.00; and,
BE IT FURTHER RESOLVED, that the Director of the Department of Finance be and hereby is
authorized to make all payments, including final payment on the Agreement.
