WHEREAS, the Purchasing Director has solicited bids for the furnishing of police supplies and ammunition for use by various departments; and,

WHEREAS, he distributed a total of twenty-seven (27) solicitations and received six (6) responses,

one of which was rejected for the failure to meet the terms and conditions of the bid; and,

WHEREAS, following evaluation of the responsive bids received, he has recommended that the contract be split and awarded to the bidders submitting the lowest and best bids for each item; and,

WHEREAS, award as recommended would result in estimated awards to the following bidders:
