WHEREAS, based on the damages sustained, Travelers Insurance paid \$249,704.00 to Jackson County, MO, on the claim, not including a \$150,000.00 deductible still due and owing; and,

WHEREAS, it is necessary for the County to pay the Kansas City Royals Baseball Corporation a total

amount not to exceed \$399,704.00, which includes the payment received from Traveler's Insurance
as well as the \$150,000.00 deductible; and,
WHEREAS, this payment is in the best interest of the health, welfare, and safety of the citizens of
Jackson County; now therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of
Finance and Purchasing be and hereby is directed to issue a check to Kansas City Royals Baseba
Corporation, in the amount of \$399,704.00, for damages sustained to Kauffman Stadium, pursuant to
