WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends the contract be made to Service Printing and Graphics of Kansas City, Missouri, for the reason that it has submitted the lowest and best bid; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County a contract with Service Printing and Graphics of Kansas City, MO, as recommended by the Purchasing Director; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract thereby made.
