RESOLUTION # 10902, July 10, 1995 INTRODUCED BY John Patrick Burnett, County Legislator
WHEREAS, there is now pending in the Circuit Court of Jackson County, Missouri, the case of Clyde Webster, et al. v. Jackson County, Missouri, et al., Case No. CV93-10456 wherein the plaintiffs seek damages against Jackson County, Missouri relative to injuries and/or deaths allegedly resulting from an automobile accident occurring in Jackson County, Missouri; and,

WHEREAS, the Jackson County Counselor has recommended that it is in the best interest of the health, welfare, and safety of the citizens of Jackson County that all of the plaintiffs' claims be settled for the payment of \$132,000.00 to plaintiffs, as more specifically explained and detailed to the Jackson County Legislature by the County Counselor in closed session related to this litigation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Counselor be and hereby is, authorized to settle the case of Clyde Webster, et al. v. Jackson County, Missouri, et al., Case No. CV93-10456 in the Circuit Court of Jackson County, Missouri, for a total payment of \$132,000.00, in full, final, and complete release of Jackson County, Missouri, and all of its employees, officers, agents, and servants; and, BE IT FURTHER RESOLVED that the Manager of the Division of Finance is authorized to issue the check of Jackson County, Missouri in the total amount of \$132,000.00 to plaintiffs pursuant to instructions of the Jackson County Counselor.
