WHEREAS, the Jackson County Purchasing Director has determined this property to be surplus; and,

WHEREAS, the Lake Lotawana Police Department has requested the donation of this property; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the specified personal property be and hereby is declared surplus; and,

BE IT FURTHER RESOLVED that the Director of Purchasing is hereby authorized to dispose of said surplus property by way of donation to the Lake Lotawana Police Department.
