WHEREAS, Mr. Mosier and his groups have consistently been recognized for their excellence by receiving the highest honor ratings and performing throughout the United States; and,

WHEREAS, Mr. Mosier has written more than 150 works for orchestra and 200 to 300 pieces for the praise band at Deerbrook Covenant Church and has most recently written the 2004 commissioned work *Out of Adullam* for the Missouri All State Orchestra; and,

WHEREAS, in his spare time, Mr. Mosier enjoys spending physically active family time with wife Lori and children Brooks, Trent, Madi and Quinn; and,

WHEREAS, Mr. Mosier will continue to nurture and develop the youth in our community as the orchestra director at Lee's Summit West High School and as instructor of music production at the pilot Entertainment Media Technology Center of Excellence; now therefore,
