WHEREAS, pet overpopulation continues to be a community problem and the Kansas City Pet Project will promote responsible pet ownership by providing animal welfare education, spay and neuter surgeries, and rabies vaccinations to those who cannot otherwise afford them, through a partnership among Spay and Neuter Kansas City, Kansas City, Missouri Animal Control, AnimalKind, and Wayside Waifs; and,

be and hereby is authorized to execute a cooperative agreement with Spay and Neuter Kansas City,
in a form to be approved by the County Counselor; and,
BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is
authorized to make all payments, including final payment on the Agreement.
