3-07 for the furnishing of rental equipment for use by the Parks and Recreation Department to

provide for departmental needs for the upcoming twenty-four month period, with two twelve-month

options to extend; and,

WHEREAS, a total of three responses were received, one of which was a "no bid;" and,

WHEREAS, following evaluation of bids, the Director of Finance and Purchasing recommends that the contract be awarded All Seasons Party Rental of Grandview, MO, for the reason that it has submitted the lowest and best bid; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the contract, to the extent that sufficient appropriations to the using spending agency have been made in the then current Jackson County budget.
