WHEREAS, the Folly Frolic event is scheduled to take place on Saturday, November 18, 2023, at 8:00 P.M. at the historic Folly Theater at 300 W. 12<sup>th</sup> Street, Kansas City, Missouri; and,

WHEREAS, the special event honors both Kansas City's long-standing impact on the birth and

WHEREAS, Take 6's superior musical artistry has been recognized with 10 GRAMMY® Awards, 10 Dove Awards, a Soul Train Award, and membership in The Gospel Music Hall of Fame; and,
