reimbursement of the County's costs for replacement of the Old 40 Highway Bridge in eastern Jackson County; and,

WHEREAS, these reimbursements represent unanticipated, unbudgeted revenues; and,

WHEREAS, the Director of Public Works recommends appropriation of the funds for availability on improvements on Colbern Road Phase II and III and other highway and bridge projects; now therefore,
