RESOLUTION # 12546, February 22, 1999

INTRODUCED BY Lisa White Hardwick, County Legislator

WHEREAS, it is necessary to replace the Major Road bridge located about mile west of Buckner Tarsney, as this bridge is one lane and load limited and eligible for replacement; and,

WHEREAS, the United States Department of Transportation has funds available for the purposes of replacing such bridge under its Off-System Bridge Replacement and Rehabilitation Program and desires to participate in the project at up to 80 percent of the costs incurred by Jackson County; and,

WHEREAS, these federal funds are distributed through the Missouri Highway and Transportation Commission; and,

WHEREAS, the attached Off-System Bridge Replacement and Rehabilitation Program Agreement will secure the funding for replacement of the bridge; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the attached Agreement is hereby approved and that the County Executive is hereby authorized to execute the Agreement on behalf of the County...Fiscal Note
