ORDINANCE # 3194, October 8, 2001

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

The Unified Development Code of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "GB" (General Business Planned Development) District so that there will be transferred from District A to District GB a tract of land described as follows:
