WHEREAS, the cost to the County under this Agreement is \$25,000.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the Agreement is hereby approved and that the County Executive is authorized to execute the agreement on behalf of

the County; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the Agreement.
