RESOLUTION #13502, January 16, 2001

INTRODUCED BY Terry Young and Ronald E. Finley, County Legislators

WHEREAS, the County and the Mid-America Regional Council (MARC) desire to enter into a Cooperative Agreement, a copy of which is attached hereto and incorporated by reference herein, whereunder the County will pay MARC \$71,000.00 to provide a variety of senior adult and youth programs and activities; and,

WHEREAS, under this Agreement, MARC is authorized to subcontract with the Don Bosco Center for an amount not to exceed \$71,000.00 to fund the Center's senior and youth activities; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Agreement is hereby approved and that the County Executive is authorized to execute the Agreement on behalf of the County; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the Agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
