WHEREAS, via Resolution 20033, dated November 5, 2018, the Legislature authorized a thirty-six month term and supply contract with two twelve-month options to extend for the furnishing of lock box services for use by the Collection Department to UMB Bank of Kansas City, MO, under the terms and conditions of Request for Proposals 58-18; and,

WHEREAS, in connection with an authorized renewal, the Director of the Collection Department recommends an increase to the scope of services provided by UMB Bank outlined in the attached Addendum and Exhibit, to allow for digital review of payment documents and digital deposit of

payments; now therefore,

BE IT RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to execute the attached Addendum and Exhibit to the contract with UMB Bank, adding a new scope of services; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the Addendum, to the extent that sufficient appropriations to the using spending agency are contained in the then current Jackson County budget.
