INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, by Resolution 12530, dated February 8, 1999, Jackson County, Missouri, and Boys and Girls Club of Eastern Jackson County (Boys and Girls Club) entered into an agreement whereby the County would provide funding to Boys and Girls Club to assist in the partial funding of its Teen Center; and,

WHEREAS, the parties desire to amend the terms of payment and enter into a First Addendum to Agreement, a copy of which is attached hereto; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, that the County Executive, be and hereby is authorized to execute the attached First Addendum to Agreement with Boys and Girls Club; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payment on the Agreement...Attorney
