A RESOLUTION authorizing the County Executive to execute an Agreement with Truman Medical Center - East, in the amount of \$210,000.00 on the recommendation of the former Jackson County Anti-Drug Sales Tax Fiscal Commission.
RESOLUTION # 11250, April 15, 1996

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the former Jackson County Anti-Drug Sales Tax Fiscal Commission was empowered by Ordinance #1771, #1795 and #1941 to make recommendations to the Legislature for the expenditure of Anti-Drug Sales Tax Funds for the purposes of treatment and rehabilitation of drug offenders; and,

WHEREAS, the Fiscal Commission reviewed treatment proposals during 1995; and,

WHEREAS, the Fiscal Commission reviewed a proposal from Truman Medical Center - East, to provide a substance abuse treatment outpatient program; and,

WHEREAS, Truman Medical Center - East, has received funding in prior years for this program upon the recommendation of the Fiscal Commission; and,

WHEREAS, during 1995 the Fiscal Commission carefully reviewed this proposal for 1996 funding from Truman Medical Center - East; and,

WHEREAS, the Fiscal Commission recommended funding in the amount of \$210,000.00 from COMBAT Funds for the proposal; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to execute the attached Agreement with Truman Medical Center - East; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payment on the Agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
