WHEREAS, the County has been awarded a grant in the amount of \$15,000 by the Missouri Department of Transportation-Office of Highway Safety for its DWI Enforcement program; and,

WHEREAS, Jackson County ranks 1<sup>st</sup> in the State of Missouri in alcohol related crashes; and,

WHEREAS, this grant will fund reimbursement of overtime used for setting up sobriety checkpoints and other alcohol related enforcement; and,

WHEREAS, an appropriation is necessary to place the grant monies in the proper spending accounts; and,

WHEREAS, the Administration recommends this appropriation as an amendment to the proposed 2005 budget; now therefore,
