WHEREAS, the City of Kansas City has requested a permanent easement totaling 327 square feet and a temporary construction easement totaling ± 13,000 square feet in conjunction with a sanitary sewer main replacement at Ess Road and Little Blue Road, with a portion of the work falling within the Little Blue Trace Park; and,

easement processing fee, per section 5099.3, <u>Jackson County Code</u> , 1984, which sets values for
easements on County park land; now therefore,

Permanent Easement and Temporary Construction Easement are hereby approved and that the
County Executive is hereby authorized to execute the Easements on behalf of the County.
