BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the aforementioned temporary construction easement, further described in the attached "Exhibit A", be and hereby is accepted and that the Manager of Finance be and hereby is directed to issue a lump sum payment in the amount of \$13,404.00 to J. Lamar and Deborah Smith and Timothy L. and Carol Schuetz in consideration for said easement.
