WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 86-97 for the furnishing of asphaltic concrete for use by the Public Works and Parks and Recreation Departments; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends the contract be divided and awarded to the three vendors submitting the lowest bids, so as to best ensure the constant availability of the materials, in all areas of the County; and,

WHEREAS, award as recommended would result in estimated awards to the following vendors:
