WHEREAS, the Legislature is desirous of continuing production services so that the Legislature's meetings can be cablecast to cable television subscribers throughout the County; and,

WHEREAS, the City of Kansas City has staff experienced in television production and is ready and willing to continue to provide these services to the County; and,

File #: 14857, Version: 0 WHEREAS, the City will also cablecast the meetings to cable television subscribers within its franchise area, and provide a videotape which can then be made available for cablecasting by other cable television providers in the County; and, WHEREAS, for the City's services, the County will pay the sum of \$1,050.00 per meeting for the period of January 1, 2004, to December 31, 2004, but not to exceed the total cost of \$50,400.00; now therefore, BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute an Intergovernmental Cooperative Agreement with the City of Kansas City, Missouri, in a form to be approved by the County Counselor; and, BE IT FURTHER RESOLVED that the Manager of the Division of Finance be and hereby is authorized to make all payments, including final payment on the Agreement. Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature. APPROVED AS TO FORM: Acting County Counselor
