AN ORDINANCE approving the preliminary plat "Churchill Estates," creating a 117-lot residential subdivision on 30.5+ acres.  
ORDINANCE 2934, July 19, 1999

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The preliminary plat "Churchill Estates," creating a 117-lot residential subdivision on 30.5+ acres, is hereby approved and described as follows:

Churchill Estates is generally located north of U.S. 24 Highway, east of the Salem East subdivision, between 18th Street North and Old Lexington Road.

Section 2. The Legislature, pursuant to the application of Ed Reese requesting the creation of a 117-lot residential subdivision and with notice that the Jackson County Plan Commission unanimously recommended this application in a public hearing May 20, 1999, does adopt this ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning. Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
