WHEREAS, the 2006 Jackson County Budget, adopted by Ordinance #3719, dated November 21, 2005, contains appropriations for certain outside agencies to provide various public parks and recreation services to the County and its citizens; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the agreements.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
