IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE amending the zoning districts established pursuant to the Unified Development Code by changing from District A (Agricultural) to District RE (Residential Estates), a certain 2.5 ± acre tract.

ORDINANCE # 3807, September 11, 2006

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "RE" (Residential Estates) District, so that there will be transferred from District A to District RE, a tract of land described as follows:

Description:

The 2.5 \pm acre lot is approximately $\frac{1}{2}$ \pm mile north of Milton Thompson Road on the east side of Howard Road and is legally described as:

Lot 18, Timber Meadows 4th Plat, a Jackson County, Missouri subdivision lying in the northeast quarter of Section 36, Township 48, Range 31 aka 10109 Howard Road.

<u>Section 2</u>. The Legislature, pursuant to the application of Robert Buxbaum (RZ-2006-406), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission unanimously recommended approval of this application at a public hearing on August 17, 2006, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
