Code; and,

WHEREAS, the Sheriff's Office has recommended the transfer of four specified vehicles to the Parks + Rec Department; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the property within the various County departments further described and itemized in the attached declaration forms, be and hereby is declared surplus, and that the Department of Finance and Purchasing be and hereby is authorized the transfer of it as indicated and as provided for in Chapter 11, Jackson County Code, 1984.
