INTRODUCED BY Ronald E. Finley, County Legislator

WHEREAS, the County and the Southern Christian Leadership Conference (SCLC) desire to enter into an agreement, a copy of which is attached hereto and incorporated herein by reference, whereunder the County will pay \$60,000 to the SCLC to be used by SCLC for funding the 2003 King Birthday Celebration; and,

WHEREAS, a transfer within the 2002 General Fund is necessary to cover a portion of this funding; and,

WHEREAS, the County Executive has recommended said transfer; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be made:
