WHEREAS, the Visit KC - the Convention and Visitors Bureau of Greater Kansas City is a not-for-

profit organization duly incorporated in Kansas City, Jackson County, Missouri, and engaged primarily in the marketing and promotion of tourism; and,

WHEREAS, this organization has shown and demonstrated evidence of its ongoing tourism marketing activities and plans for promotion of Jackson County; and,

WHEREAS, this organization requires formal acknowledgment and recognition by the County Legislature to become a qualified participant in the programs administered by the Missouri Division of Tourism; and,

WHEREAS, the designation re-certification will be for a one-year term beginning July 1, 2017, through June 30, 2018; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature hereby designates and recognizes the Visit KC - the Convention and Visitors Bureau of Greater Kansas City as the representative organization to solicit and service tourism in Jackson County, Missouri, for the Missouri Division of Tourism's program.
