ORDINANCE #4064, November 24, 2008

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, the U. S. Department of Justice has awarded the County and the Cities of Independence and Kansas City, and the Board of Police Commissioners of the City of Kansas City, a grant in the total amount of \$291,576.00 to provide for anti-drug and other crime control measures for the period of October 1, 2007, to September 30, 2011; and,

WHEREAS, the grant allocates \$129,731.50 to the County, for salaries and benefits for the employees of the Jackson County Drug Court Program, and requires that the County pass through \$161,844.50 to the other cities and agencies; and,

WHEREAS, this grant requires no local matching funds, but does require the execution of the attached Interlocal Agreement with the aforementioned cities and agencies; and,

WHEREAS, an appropriation is necessary in order to place the grant funds in the appropriate spending accounts; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the fund balance of the 2008 Anti-Drug Sales Tax Fund be and hereby is made:
