WHEREAS, contractors were required to submit bids for two options, one which allowed the closure of the intersection during June, July, and August, 2009, and one to construct the entire project while

adjustments which may become necessary under this contract to the extent there is no additional					
cost to the County; and,					
BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all					
payments, including final payment on the contract.
